Re: Reederei Rudolf Schepers GmbH & Co KG and Iran

Dear Mr. Schepers:

On behalf of United Against Nuclear Iran ("UANI"), I am writing to you to express my concerns about the apparent calling of Reederei Rudolf Schepers GmbH & Co KG's ("Reederei Rudolf Schepers") vessel "TS Jakarta" (IMO 9383223)¹ at Iranian ports that appear to be operated by sanctioned entities under recent European and U.S. legislation.² The international community has become increasingly concerned by the regime's refusal to comply with demands to alleviate concerns about its possible pursuit of nuclear weapons. In the framework of the ongoing diplomatic effort between the P5+1 and Iran, the international sanctions regime and its effective implementation play a crucial role as a means of leverage for international negotiators. Therefore, we would like to share with you our concerns about the apparently ongoing interaction between your vessel, the "TS Jakarta" (IMO 9383223) and port authorities that appear to be closely affiliated with Tidewater Middle East Co., a U.S. and EU sanctioned Iranian entity.

The container ship "TS Jakarta" (IMO: 9383223) which is group-owned and managed by Reederei Rudolf Schepers and directly owned by Rudolf Schepers subsidiary Anna-S, appears to have visited ports reportedly operated by Tidewater Middle East Co.³ Tidewater Middle East Co. was sanctioned by the EU and U.S. due to its connection to the Iranian Islamic Revolutionary Guard Corps ("IRGC"). The IRGC itself is sanctioned by the EU and is designated as an entity of proliferation concern by the U.S.⁴ Thus by continuing its interaction with this Iranian port management authority, Reederei Rudolf Schepers could be in danger of inadvertently violating EU sanctions. Any payments to Tidewater Middle East

Co. are prohibited under aforementioned sanctions.⁵ As part of UANI's general campaign, we encourage Reederei Rudolf Schepers to consider abandoning its alleged interaction with sanctioned Iranian entities in order to avoid any further reputational damage derived from its ostensible commercial activities there.

Although Reederei Rudolf Schepers' operations in Iran are ostensibly civilian, private sector interactions, we have a number of reservations with such alleged ongoing cooperation. In particular we are concerned about the following elements of your interaction with Iranian entities, which are notably corroborated by different open source ship monitoring websites themselves based on vast amounts of Automatic Identification Systems (AIS) data:

- According to the website Fleetmon.com, "TS Jakarta" (IMO: 9383223) has been calling at Bandar Abbas and Bandar E-Shahid Reajie ports repeatedly between September 2012 and June 2013, spending over 36 hours in the Bandar E-Shahid Reajie port area as recently as 5/9/2013 11.05.2013⁶.
- The website Fleetmon.com showed "TS Jakarta" (IMO: 9383223) indicated Bandar Abbas as its last destination on 12/11/2012⁷.
- The website marinetraffic.com showed that "TS Jakarta" (IMO: 9383223) indicated Bandar Abbas as its next destination via AIS on 6/25/2013⁸.

Furthermore, Reederei Rudolf Schepers, as the registered agent to the owner and manager of vessel "TS Jakarta" (IMO: 9383223) should be aware of the risks involved in permitting the vessels to call at Iranian ports and not exercising due diligence in verifying the nature of cargo, cargo interests, charterer, port agents and port operators. By allowing one of its vessels to call at Iranian ports, Reederei Rudolf Schepers might find itself in breach of European sanctions and, simultaneously, be in danger of inadvertently helping Iran to circumvent the multilateral sanctions that have been imposed to prevent the country from further developing its possible nuclear weapons program and to motivate it to improve its human rights record.

In light of these concerns, UANI calls upon Reederei Rudolf Schepers to follow the lead of other multinational companies, such as Maersk Line,⁹ and end port calls of its vessels to Iran. We are convinced that such behaviour is the only responsible course of action in the current circumstances. Without wide ranging cooperation from the private business community, it is impossible to maintain and increase the fiscal and economic pressure on the Iranian regime, which continues to advance its nuclear program. The sanctions imposed on Iran by the U.S. and the EU as well as a host of other nations at the beginning of 2012 were one of the central factors which motivated Iran to return to the negotiating table after a 15 month hiatus. Increasing the economic pressure on the regime is the best chance to motivate Iran to agree to concrete concessions that can pave the way to a peaceful resolution of the conflict. If the current negotiations do not lead to a compromise that halts Iran's nuclear activities, the Persian Gulf is in danger of fundamentally destabilizing over the long term.

These tensions might ultimately lead to war, which will wipe out any commercial interests that companies such as Reederei Rudolf Schepers hold in the wider Middle East. Therefore, a planned and organized cessation of your company's vessels' port calls to Iranian ports may be the appropriate and prudent long-term business strategy.

Please let us hear from you by August 1, 2013 about Reederei Rudolf Schepers' intentions with respect to its business in Iran. We look forward to your response.



Appendix 1: Ownership structure of TS Jakarta (equasis.org) [accessed on: 28.06.2013]


